Airline Information

The price for the “Short Tour” and “Long Tour” **do not** include the cost of the airline to and from Providence, or New York City if you are going on the Long Tour.

With safety being the number one concern, girls may not fly alone, and need to have an adult accompany them on the flight.

After the deadline date for signing up has passed, a list of all travelers will be sent out along with their departure airport and contact information. Each group leaving from the same airport can work together to arrange flights.

Our travel agent can arrange flights for you if you wish, but there is a fee of \$35.00.

It is strongly recommended that before submitting this application, each traveler research flights to Providence and home. Flight costs vary greatly from airport to airport. It is important that each traveler knows the total cost of the trip prior to booking. Don't forget, most airlines charge \$25 per bag.

As already mentioned, the cost of the trip does not include air fare, but also does not include most meals. On the Short Tour one breakfast, two lunches, and two dinners are included. No meals on the Long Tour are included. Please consider this along with other expenses when planning your travel budget.

Planning your Flight

Home to Providence – your flight needs to arrive on Friday, July 29th, between 4:00 PM and 10:00 PM. We will be flying to T. F. Green Airport (PVD) in Providence, Rhode Island.

Providence to Home – Flights need to depart on Wednesday, August 3rd after 3:00 PM. If you desire an earlier flight you would need to spend an additional night in Providence and depart on Thursday. There would be an additional charge for the hotel.

New York City to home – Flights depart on Sunday, August 7th after 3:00 PM. We will be flying out of Kennedy Airport (JFK)
