ASSUMPTION OF RISK AND RELEASE

I/We fully release, discharge, and agree to defend, indemnify, and hold harmless Rainbow Girls, including its officers, agents, employees, managers, independent contractors, parent organizations, subsidiaries, affiliates, and personnel (collectively "Released Parties") from any and all claims, demands, or causes of action in any way connected with Participant's participation in any Rainbow Girls event or Participant's use of any Rainbow Girls facility or convention facility (collectively "Facility") amenities, services, or facilities, including without limitation any such claims that allege or prove negligent acts or omissions of the Released Parties and/or third parties. This includes without limitation claims that allege or prove that any causation or incident was caused by the Released Parties' sole or contributory negligence and/or claims that allege or prove that the incident was caused solely or partly due to negligent design, construction, condition, maintenance, or repair of the Facility's amenities, equipment, or facilities.

I/We voluntarily assume all risks of personal injury, including temporary or permanent disability or death, property damage, economic losses, and/or other damages to Participant and/or the undersigned resulting from or in any way associated with Participant or undersigned's participation in any Rainbow Girls event or use of the Facility's amenities, services, and facilities, or participation in any of the activities at any Rainbow Girls event.

I/We further release and discharge the Released Parties from, and agree and covenant not to sue the Released Parties for, any claim, liability, or demand of any kind or on account of any personal injury, temporary or permanent disability, death, property damage, economic losses, and/or other damages to Participant or the undersigned, whether caused by the negligence of the Released Parties or otherwise, resulting from or in any way associated with Participant's entry onto the Facility's premises, use of the Facility's amenities, services, and facilities, or participation in any Rainbow Girls event. Further, the undersigned agrees and covenants to indemnify and hold harmless the Released Parties for and from any such claims, liabilities, demands, fees, or costs, including without limitation attorney fees at trial and on appeal.

I/We agree that if a lawsuit is filed against any of the Released Parties, such filing shall be solely in Pierce County, Washington, and that the substantive law of Washington shall apply in that action without regard to conflict of law rules. I/We also agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. The undersigned has full authority as parent or legal guardian to bind Participant to all terms of this agreement and the undersigned and all releases, waivers, covenants, and agreements herein are binding on Participant and the undersigned.
