

CA SUPREME TOUR 2022

The 49th Biennial "Light the World with Hope and Peace" 100th Centennial Supreme Assembly Session will be held in Oklahoma City, OK. We would love for you to be a part of the CA delegation attending Supreme Assembly.

You may select from 2 options if you would like to attend:

Main Tour runs from Friday, July 29 to Thursday, August 4. The Tour includes a trip to the Supreme Temple in McAlester, OK. We will tour the Supreme Temple, enjoy lunch, tour the Rainbow Reflections Memorial and Walkway and drive by many sites including W. Mark Sexson's family home. On another day we will be visiting the Oklahoma City Memorial. The Main Tour will also include the Supreme Birthday Block Party, Supreme Banquet, our jurisdictional breakfast, the Supreme sessions, bus pass from hotel to the convention center where sessions will be held, ending with Supreme Installation. Airfare to and from Oklahoma City as well as airport transfers will be on your own. Those who choose this tour will return home Thursday, August 4. Hotel Checkout is 11am on Aug. 4.

Extended Tour runs from Friday, July 29 to Friday, August 5. This Tour includes everything from the Main Tour listed above. This tour includes a trip to Pawhuska, OK on Thursday, August 4. We will board the chartered bus and leave at 7:30am. Pawhuska is approximately 2 hours away and is the headquarters of the Osage Nation. We will enjoy the town and the many sites to see. Our group will enjoy a catered lunch at the Pioneer Woman Mercantile Special Events Center. We will then enjoy a narrated bus ride around the area with a local tour guide who will explain the history of this area and the Osage Nation and show us the important sites. We will return to our hotel around 6:30pm. Those who choose this tour will return home Friday, August 5. Hotel Checkout is 11am on Aug. 5.

Costs are based on the number of each person in the room.

We will be staying as a jurisdictional unit at a hotel selected by Supreme in Oklahoma City, OK. Girls must have their parents and Grand Deputy sign their application. There is also a medical form which will be sent after your application is received.

The above price for the Main Tour and Extended Tour **does not** include airfare or airport transfers. You are responsible for booking your own travel to and from our hotel in Oklahoma City. The closest airport is OKC (Oklahoma City, OK). You will use Uber or taxi to get to and

from the hotel. Members must travel with an adult to and from Supreme. There will be no exceptions to this important safety protocol.

Other important details:

Hotel check in on Friday, July 29 will begin at 3pm. I will be checking in our group and distributing keys.

Please arrive at the hotel on Friday, July 29 by midnight. Our tour to the Supreme Temple departs promptly at 7:30am on Saturday, July 30.

Airlines may charge \$25 per checked bag.

Meals: On the Main Tour: One breakfast, two lunches and one dinner. An additional lunch will be included on the Extended Tour. You will be responsible for your other meals.

Dress: We will have matching travel shirts. Price and ordering information will be sent to each traveler at a later date. They are required as we will wear these with a skirt at several Supreme Sessions. We will wear our royal blue formal attire to the Supreme Banquet and one other session at Supreme Assembly. Supreme Assembly dress code will be in effect. All leisure time clothing must be Rainbow Appropriate. Jeans and bathing suits must follow dress code guidelines. Slacks and shorts may not be worn in the Convention area at any time during the Supreme Assembly Session. Neat walking shorts or slacks may be worn on arrival and departure from the hotel or when going to and from local activities or tours. Short shorts are not to be worn at any time.
