PARTICIPANT MEDIA AUTHORIZATION AND RELEASE FORM

I hereby agree to release, defend, and hold harmless IORG and subordinates, including any firm publishing and/or distribution the finished product in whole or in part, whether on paper or via electronic media, from and against any claims, damages or liability arising from or related to the use of the photographs or videos, including but not limited to any misuse, distortion, blurring, alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in taking, processing, reduction or production of the finished product, its publication or distribution.

I hereby agree that images or recordings remain the property of IORG. This media release is not event or time specific; rather it shall serve as a general release for all photo, video and/or voice opportunities during the undersigned's participation with the IORG. All media of IORG activities will be stored and kept for future use under these general guidelines. It is the responsibility of the parent/guardian for the youth participant whose permission is granted here to inform IORG in writing directed to the Supreme Officer in California, if they wish to rescind permission to post pictures of the participation in IORG activities as recited above.
